PAYMENT TERMS: (see attached Rider)

This contract constitutes a binding agreement between the PURCHASER and ARTIST afore mentioned and is governed under the laws of the State of Tennessee. It is further mutually agreed that the “Contract Rider” attached to this page are hereby made part of the contract, and have been read and fully understood by both parties. Please sign each copy individually. In the event of a breach of this contract by PURCHASER, PURCHASER agrees to pay the full wage agreed upon, attorney’s fees, legal interest, and court costs.

PURCHASER AND ARTIST AGREE THAT THIS CONTRACT IS NOT SUBJECT TO CANCELLATION, EXCEPT WRITTEN AGREEMENT BETWEEN THE PARTIES AND SENT TO THE RESPECTABLES. It is further agreed that any cancellation by PURCHASER will result in the forfeiture of the PURCHASER’s deposit, in addition to any other remedies enumerated in the contract or afforded by law to the ARTIST.

This instrument contains the entire agreement between the parties and no other statements, promises, or inducements made by either party or their representatives, not contained in the written contract, shall be valid or binding. This contract shall not be enlarged, or modified or altered except in writing signed by the parties and endorsed hereon.

SOUND AND LIGHTS TO BE PROVIDED BY: ARTIST

PURCHASER is liable for any and all damages to ARTIST’s equipment caused by PURCHASER’s guests, members or invitees.

PURCHASER and ARTIST agree that if either party should be required to report to a court of law to enforce any or all provisions of this contract, that the costs and expenses shall be the responsibility of the one who is found in breach of this contract by the court of law.

CONTRACT RIDER

The following Rider is to be attached and made part of the contract between Purchaser and The Respectables. This rider is made part of the performance contract in order to insure that most successful engagement possible.

Stage: stage area will be accessible to the ARTIST’s crew at least Three (3) hours prior to the arrival of guests. PURCHASER will provide a stage or area preferably of the following dimensions: 12’ deep x 16’ wide (this equals 6 standard 4x8 staging panels). The stage will be of sturdy construction and will support the musical and dance performances safely. The stage should be leveled to the horizon when erected on an uneven slope or hill. ARTIST will not play directly on the grass/dirt.

Electrical requirements: ARTIST will require access to nearby (within 20 feet) electricity of at least Two (2) dedicated 20 amp circuits that are not being shared for other uses.

Dressing / Changing Room: PURCHASER will provide ARTIST with a private changing room.

Food / Beverage: Meals are always appreciated. PURCHASER will arrange for ARTIST to use the same beverage and food service as the guests or pre-arrange a “vendor meal” with caterer.

Parking: PURCHASER will arrange free parking to ARTIST within close vicinity of event.

Outside Event: ARTIST can perform outside. ARTIST will not perform in rain, or temperatures below 45 degrees Fahrenheit. ARTIST will require a dry, level stage (not directly on grass/ground), and access to nearby (within 20 feet) electricity of at least two (2) dedicated 20 amp circuits that is not being shared for other uses. **It will be PURCHASER’S responsibility to provide ARTIST adequate protection from the elements (inclement weather, direct sunlight, etc).** Any roofed structure/tent with at least 10 feet distance between the band and the edge of roof, or a tent with sides is considered adequate. In case of inclement weather after the start of the event, ARTIST will not be required to strike stage and set up in alternate location. If ARTIST is directed to set up outside without adequate protection and it does rain, ARTIST reserves the right to cancel performance for the duration of the event due to risk of electrocution and risk to ARTIST’S equipment. Full payment will still be due to ARTIST.

Will the engagement be inside or outside? _____

Payment Terms: Payment will be made via cash, check or money order to ARTIST prior to the last set on the evening of the engagement. Checks will be made payable to “The Respectables”. If an invoice is necessary for PURCHASER’S records, PURCHASER will notify ARTIST at least one (1) week in advance so that an invoice can be paid prior to the end of the engagement.

During breaks in live performances, music will continue via DJ unless otherwise notified.

ARTIST obligations are subject to detention or prevention by sickness, inability to perform, accident, Acts of God, riot strikes, any act of public authority, labor difficulties, of any cause beyond the ARTIST’S control. In such case, there shall be no claim of damages by either party to this contract, and any deposits will be refunded in full.
